


## Use ctcLink on your Mobile Device: Get the App








Here we are using Seattle Central College as the example, but the app works exactly the same for North and South Seattle College, too.

Step 3: Select your Institution from the list. Scroll to see more options.




Click on the tiles to log in to ctcLink. You can also Browse Classes or view other important sites such as Office 365, Canvas, and Starfish.




Log in to your account.
